Permanent Partial Disability (PPD)

Thumb.....	60 wks.
First finger (index finger).....	35 wks.
Second finger.....	30 wks.
Third finger.....	20 wks.
Fourth finger (little finger).....	15 wks.
First phalanx of thumb/finger.....	one-half
compensation for entire thumb/finger	
<i>Loss of more than one phalanx of a</i>	
<i>thumb/finger is deemed loss of the entire</i>	
<i>thumb/finger. Amounts received for loss of</i>	
<i>more than one finger shall not exceed</i>	
<i>compensation provided for loss of hand.</i>	
Great toe.....	30 wks.
Other toe.....	10 wks.
First phalanx of any toe.....	one-half
compensation for loss of entire toe	
<i>Loss of more than one phalanx of toe is</i>	
<i>deemed loss of the entire toe.</i>	
Hand.....	150 wks.
Arm.....	200 wks.
Foot.....	125 wks.
Leg.....	175 wks.
Total vision loss (one eye).....	100 wks.
Total hearing loss (one ear).....	50 wks.
Disfigurement.....	maximum 60 wks.
Pneumoconiosis, including but not limited to	
silicosis and asbestosis, medically determined

First Stage.....	50 wks.
Second Stage.....	100 wks.
Third Stage.....	300 wks.
Byssinosis.....	50 wks.
